Safety Update: Karen Collins let members know that the requirements from House Bill 496 stating students grade 7 and up should be offered a class on Stop the Bleed/Traumatic Injury Response were met today as class was offered in EMS cafe 11/4/19 taught by Danny Anthony (chief of fire Lavon), 2 students attended.
